

**TOWN FOREST COMMITTEE  
MINUTES**

**DATE:** WEDNESDAY, MAY 6, 2009

**MEMBERS PRESENT:** ED WHITE, CHAIR; FRED MULLEN, TREASURER; JEFF CROSBY, VICE-CHAIR; RON JARVIS, SECRETARY

**MEMBERS ABSENT:** JACQUES BELANGER

**PREVIOUS MINUTES:** MINUTES FROM THE FEBRUARY 4, 2009 MEETING WERE ACCEPTED AS READ.

**TREASURER'S REPORT:** TREASURER, FRED MULLEN REPORTED THAT AS OF APRIL 21, 2009, THE TFC TREASURY CONTAINED \$172,694.63. THE TREASURER'S REPORT WAS ACCEPTED AS READ.

**OLD BUSINESS:** FRED MULLEN AND RON JARVIS INSTALLED THE 3 N.H.T.O.A. SIGNS AT THE TFC WOOD LOTS ON KIMBALL POND ROAD.

**NEW BUSINESS:** ED WHITE SUGGESTED A CLEAN-UP SESSION TO MAKE THE WINSLOW MARKER AND ITS SURROUNDINGS LOOK NEATER.

JEFF CROSBY NOTED THAT ON RAY ROAD THERE ARE A FEW DAMAGED TREES AS WELL AS SOME TOO CLOSE TO THE ROAD. SOME OF THESE INTERFERE WITH PLOWING SNOW EACH YEAR. SINCE SOME OF THE TREES ARE ON TFC CONTROLLED LAND, HE ASKED IF THE COMMITTEE WOULD ALLOW A LOGGER WORKING IN THE AREA TO TAKE THE TREES DOWN FOR THE TOWN. THE LOGGER, JOHN RICHARDSON SAID HE WOULD TAKE THE TREES DOWN FOR FREE IF HE COULD HAVE THE LOGS. THE COMMITTEE VOTED TO ALLOW THE TREES TO BE CUT.

**CORRESPONDENCE:** RON JARVIS RECEIVED AN E-MAIL FROM MR. & MRS. FARMER WHO SAID THEY WERE NOT SURE WHAT THEY WILL DO WITH THE EVERETT DAM RD. LOT, BUT THEY WERE OPEN TO DISCUSSION CONCERNING ITS FUTURE.
