

**TOWN FOREST COMMITTEE
MINUTES**

DATE: WEDNESDAY, AUGUST 2, 2006

MEMBERS PRESENT: ED WHITE, CO-CHAIR; RON JARVIS, SECRETARY; JEFF CROSBY; FRED MULLEN, TREASURER;

MEMBERS ABSENT: JACQUES BELANGER

PREVIOUS MINUTES: MINUTES FROM THE MAY 3, 2006 MEETING WERE ACCEPTED AS READ.

TREASURER'S REPORT: THE TREASURER'S REPORT STATED THAT, AFTER PAYING JACQUES BELANGER \$2122.50 FOR THE SURVEY WORK AT STARK PIT AND RECEIVING \$162.20 FROM JOHN CONDE, THE JUNE 30, 2006 BALANCE, WITH INTEREST WAS \$127,101.36. THE REPORT WAS ACCEPTED AS READ.

OLD BUSINESS: FOR CLARIFICATION OF THE ABOVE \$2122.50 BILLING, THE FOLLOWING APPEARED IN THE MINUTES OF THE MAY, 2006 MEETING. "JACQUES BELANGER WHOSE COMPANY WAS HIRED ON FEBRUARY 1, 2006, TO DEVELOP A PLAN TO CLOSE STARK PIT IN COMPLIANCE WITH THE DECISION MADE BY THE SOCIETY FOR THE PROTECTION OF NEW HAMPSHIRE FORESTS, SHOWED THE COMMITTEE A TOPOGRAPHICAL MAP OF THE PIT. A DISCUSSION ENSUED CONCERNING POSSIBLE METHODS OF RECLAIMING THE PIT." THE BILL JACQUES PRESENTED WAS FOR THE PRELIMINARY ENGINEERING.

NEW BUSINESS: JACQUES BELANGER WAS APPOINTED TFC REPRESENTATIVE TO THE *KUNCANOWET TOWN FOREST AND CONSERVATION AREA* (KTFCA) MANAGEMENT COMMITTEE.

THE TFC VOTED TO EXPEND A MAXIMUM OF \$75 FOR A *JOHN SWINDLEHURST* SIGN FOR A FIRE TRUCK.

THE TFC DISCUSSED PUTTING SIGNS ON THE BOUNDARIES OF EACH OF THE TOWN FOREST LOTS.
