

**TOWN FOREST COMMITTEE  
MINUTES**

- DATE:** WEDNESDAY, NOVEMBER 1, 2006
- MEMBERS PRESENT:** ED WHITE, CHAIR; JEFF CROSBY, VISE-CHAIR; FRED MULLEN, TREASURER; RON JARVIS, SECRETARY; JACQUES BELANGER
- MEMBERS ABSENT:** NONE
- PREVIOUS MINUTES:** MINUTES FROM THE AUGUST 2, 2006 MEETING WERE ACCEPTED AS READ.
- TREASURER'S REPORT:** THE TREASURER'S REPORT STATED THAT THE T.F.C. RECEIVED THE FOLLOWING FROM JOHN CONDE; JULY 9, \$650.92; JULY 23, 4586.41; JULY 31, \$602.38. ON JULY 15<sup>TH</sup> PAID \$85.00 FOR A COMMEMORATIVE PLAQUE FOR HONORING JOHN SWINDLEHURST. AS OF SEPTEMBER 30<sup>TH</sup>, THE T.F.C. HAD \$129,836.81 AS REPORTED BY CITIZENS BANK. THE COMMITTEE RECEIVED ANOTHER PAYMENT FROM JOHN CONDE OF \$505.02 FOR A TOTAL OF \$130,341.83. THE REPORT WAS ACCEPTED AS READ.
- OLD BUSINESS:** THE T.F.C. VOTED TO PAY AN ADDITIONAL \$10.00 FOR GOLD LETTERING FOR THE PLAQUE ON THE FIRE TRUCK.
- NEW BUSINESS:** MR MARC KOLOPSKY FROM AMERIPRISE FINANCIAL SERVICES ADDRESSED THE T.F.C. AND EXPLAINED OUR OPTIONS FOR THE INVESTMENT OF THE COMMITTEE'S FUNDS. THE T.F.C. WOULD BE ABLE TO EARN HIGHER THAN BANK INTEREST RATES YET WITH THE PROPER ACCOUNT STILL HAVE CASH FLUIDITY WITH A BRIEF NOTIFICATION PERIOD.
- A MOTION WAS MADE, SECONDED AND PASSED TO PLACE THE TOWN FOREST COMMITTEE TREASURY WITH AMERIPRISE FINANCIAL SERVICES.

**CORRESPONDENCE:**

NOTIFICATION FROM THE PLANNING BOARD THAT KIM SCHUMACHER IS PROPOSING A LOT LINE ADJUSTMENT BETWEEN HER TWO PARCELS WHICH ARE LOCATED SOUTH OF THE TOWN FOREST LAND ON KIMBALL POND ROAD. RON JARVIS EXPLAINED THAT PREVIOUS ISSUES WITH THE SOCIETY FOR THE PROTECTION OF NH LANDS HAD BEEN ADDRESSED AND THAT THERE WAS NO LONGER AN IMPEDEMENT TO THE LOT LINE ADJUSTMENT WHICH WOULD HAVE HAD NO EFFECT ON THE TOWN FOREST.
