**DUNBARTON BOARD OF SELECTMEN  
MINUTES OF MEETING  
TUESDAY, DECEMBER 22, 2015  
TOWN OFFICES - 7:00 P.M.**

The Dunbarton Board of Selectmen held the scheduled Workshop meeting of the Dunbarton Board of Selectmen at the above time, date and place with Brian Pike, Chairman, presiding.

The following were present:

Brian Pike, Chairman, called the meeting to order at 7:05 p.m. with a full Board present and Line Comeau, Town Administrator, and Alison Vallieres, Recording Secretary.

The Board of Selectmen reviewed the Health Trust plan options.

Ted Vallieres suggested that the Board look into Aflac and the plan which they offered where the Town was self-insured and they covered the deductibles through a pool.

Ted Vallieres will check with Aflac to find out more and see if they could come to the Board of Selectmen for a discussion of their health plans, etc.

After considerable discussion, the following motion was made:

***MOTION:***

*Tom Groleau made a motion that the Dunbarton Board of Selectmen take option AB20 with the Prescription Plan of R10/25/40, M10/40/70, at the \$815.15 for a single person plan, \$1,630.30 for a two person plan, and \$2,200.91 per month for a family plan. Brian Pike seconded the motion. The motion passed unanimously.*

**DAM SKLUT, POLICE CHIEF RE DISPATCH ARRANGEMENTS:**

Dan Sklut, Police Chief, appeared before the Board of Selectmen to bring them up to date on the latest developments with regard to the new dispatch arrangements with Goffstown.

He noted in the beginning, there was a possibility of being charged up to \$500 per month for a telephone line for the dispatch phone. Recently, it has been determined that the signal can be sent to Goffstown from the antennae via a radio signal instead of using a telephone.

The estimated cost for this will be \$7,073 for the receiver including installation and \$6,000 for the radio system for a total of no more than \$12,000 - \$13,000.

Dan Sklut noted that he would have sufficient monies remaining in his 2015 budget to cover this expense due to the secretarial, and other budget lines.

Ted Vallieres stated he would rather see the Board of Selectmen authorize the use of Unanticipated Revenues for the cost for the dispatch rather than utilize the Police Department budget for 2015.

**The following motion was made:**

***MOTION:***

*Brian Pike made a motion that the Dunbarton Board of Selectmen authorize the payment for the radio upgrade from Unanticipated Revenues. Tom Groleau seconded the motion. The motion passed unanimously.*
